

## Informed Choice and Disclosure Statement for Kaufman County Birth Center Associate Midwives

According to the Texas Law, Texas Occupations Code Cg.203, the Midwife is required to disclose in oral and written form to a prospective client the limitations of the skills and practices of the Midwife. The informed choice and disclosure statement meets these legal requirements.

In accordance with the Texas Midwifery Act, as midwives we:

Assist only with normal childbirth except in an emergency situation that poses an immediate threat to the life of the mother or newborn.

Encourage each client to seek prenatal, postpartum, and newborn care.

Advise each client to seek medical care if the client develops signs or symptoms of a complication related to pregnancy.

Do not use forceps or surgical instruments for any procedure other than cutting the umbilical cord or providing emergency first aid during delivery.

Do not remove the placenta by invasive technique.

Do not advance or retard labor or delivery by using medicines or mechanical devices.

Do not administer a prescription drug except under the supervision of a physician licensed by the State of Texas, with the exception of oxygen and state approved prophylaxis to prevent blindness of the infant.

Do not knowingly or intentionally falsify or make false statements on a birth certificate application.

Do not use professional titles other than licensed midwife (LM) or Certified Professional Midwife (CPM) if NARM certified.

Have made the form available in English and Spanish.

Have made the statistics specified by the Texas Midwifery Board available (see below)

Have explained to the client all the other legal requirements which are applicable to the midwifes practice;

- o The newborn screening law requires every newborn to receive testing for certain diseases. We are trained to do compulsory newborn screening.
- o A newborn baby must receive eye prophylaxis within 2 hours of birth to prevent possible blindness from infection.
- o A serology blood test for syphilis & hepatitis B is necessary during pregnancy and on admission for birth.
- o A serology blood test for HIV is necessary at the first prenatal visit and on admission for birth, unless the mother objects. The result of the test is confidential.
- o Communicable diseases must be reported.
- o Registration is necessary for both births and deaths.
- o Compliance with provisions of the Dangerous Drug Act and the controlled Substance Act is necessary and other laws applicable.
